Notice Period: A Calendar month's notice is required for students who joined the school within 1 – 3 months of attendance and a full term's written notice is required for students attending longer than 3 months if you intend to remove your child from the school. This notice must be written and handed in during the last week of the month before the notice month or of the term before the notice term.

The Account Holder undertakes to give the school thirty (30) calendar day's written notice of termination of the enrolment of all primary school additional services, i.e. aftercare, transport, etc. failing which, the account holders and the surety and co-principal debtor shall be liable for the full amount of the tuition fees for the following month.
